By Laws

ByLaws are ready to be sent to the general population after a few minor corrections; in preparation for the general meeting. Jeff pointed out that the name of the organization in Article 1 Section 1 needs to match the name on our articles of incorporation: Westgrove PACK, LLC. Marissa and Mark need to review the bylaws before they are approved by the board. Marissa thinks that bylaws should be reviewed with each new board. Liz concurred. Treasurer report: we spent what we raised in 2017. Liz discussed membership, both continuing caretakers and yearly caretakers and the fact that they meet the bare minimum.
